SPECIFICATION:

Service Providers are requested to submit a quotation to supply, install 1 Audio- Visual monitor and load content (7 interviews reduced to 3 minutes each) in the monitor and install 1 Audio Equipment for installation of a 4 mb and 4 min speech of Ruth First)

AV Hardware Specifications

- **Resolution:** Use a minimum of **Full HD (1920x1080)**. For high-bitrate video or detailed digital art, **4K (3840x2160)** is recommended to ensure visual clarity and sharpness.
- **Panel Type:** Prioritize **IPS (In-Plane Switching)** or **LED** panels for wide viewing angles (at least 178°) and high color accuracy.
- **Durability:** Select **commercial-grade presentation monitors** designed for constant playback (24/7 or 16/7), as they offer higher durability and professional video inputs compared to consumer TVs.
- **Aspect Ratio:** Ensure the monitor matches the content's native aspect ratio (typically **16:9**). Avoid "pan and scan" or zooming, as these cause image distortion.

2. Audio Installation

- **Speaker Setup:** Professional presentation monitors often lack built-in speakers. Pair with **self-powered or amplified external speakers**.
- **Acoustics:** Use **directional speakers** or **hidden speakers** to focus sound on the visitor and minimize "audio bleed" into other exhibit areas.
- **Accessibility:** Provide **headphone jacks** or location-aware sound technology for a personalized experience.

3. Mounting and Placement

- **Viewing Height:** Mount the monitor at **eye-level**, approximately **60–65 inches** from the floor for standing adults. For inclusivity, ensure key content is visible to children and wheelchair users.
- **Viewing Angle:** For interactive touchscreens, angle the display **upwards** to encourage engagement. For passive storytelling with longer viewing times, angle the display **downwards** to capture attention.
- **Room Lighting:** Position the screen away from windows and direct light sources to prevent **glare**. Use matte screen filters or anti-reflective glass if necessary.

4. Integration and Connectivity

- **Playback Device:** Use a **dedicated media player** (e.g., Raspberry Pi with software like [Info Beamer](#)) or a **Content Management System (CMS)** for remote scheduling and automatic power cycling.
- **Cabling:** Use **HDMI** or **USB-C** for high-quality audio and video transmission. USB-C can also provide power and data transfer through a single cable.
- **Concealment:** Hide all electrical outlets and data cables behind the display or within an **AV cabinet** to maintain aesthetic harmony.

5. Accessibility and User Experience

- **Contrast and Design:** Maintain a high contrast ratio (at least **4.5:1**) and use legible, on-brand fonts (minimum 18–24 points for body text).
 - **Engagement:** Structure narratives into easy-to-follow segments (storyboarding). Use **progressive disclosure**—showing a summary first and allowing users to interact for deeper content.

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

1.2 **To be completed by the organ of state**

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”**
means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
