The event will take place on 26 June 2026 – an event will be held in celebration of the 30 years of the Constitution at Freedom Park in Pretoria. provision of public address system:

- Screens

- Online video live streaming of the event; and
- Venue lighting and staging

- Stage approximately 4m(L) X 3m(W) X 400mm(H) with ramp & stairs.
- PA System with speakers and able to play background music

PROVISION OF VIDEO, VIDEO LIVE STREAMING SERVICES AND A LECTERN

- The service provider is expected to provide an appropriate public address system for event.
- One (1) microphone on stand for the lectern.
- Three (3) roving microphone.
- Minimum of two speakers
- Minimum five (5) channel mixer for video and audio output for media personnel to get live feed.
- 3 x Video camera to project speaker the Venue's screens
- 1 x videographer
- The videographer will be responsible for taking and broadcasting live visuals from another part of the venue, for a wreath laying ceremony to be broadcast to the inside the venue and for live streaming of said ceremony.
- Basic mood lighting
- Lectern (white Perspex)
- The service provider is expected to arrive at the event venue and be set up no later than 06h30. The final sound check will be at 08h00. Ideally the service provider should set up the day before.
- Provide online video live streaming of the entire event programme. The online video live streaming will be done via the OCJ's YouTube – Judiciary RSA.
- The service provider is expected to have a premium Zoom subscription that allows event attendance numbers of no less two hundred (200) delegates.
- The successful service provider will receive a detailed brief from the OCJ.

EXPECTED OUTPUTS

- A fully functional public address system.
- An audio deck/mixer that will provide an audio feed to television and radio broadcasters.
- A premium subscription Zoom package that can accommodate no than two hundred (200) attendees.
- A live streamed online live event on the RSAJudiciary YouTube channel.
- The edited final videos should include the branding as per the 30 years of the Constitution Celebration Corporate Identity. The relevant files will be provided to the supplier.
- Edited on site mini-videos throughout the conference, a minimum of five (5) to be produced.

- A full briefing will be conducted.
- Lighting
- One (1) x Stage Microphone and Three (3) x roving mics.
- Lectern
- Stage approximately 4m(L) X 3m(W) X 400mm(H) with stairs.

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”**
means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
